If you are an employee of a Minnesota government unit, data about you are classified as either public or private.* This notice is required by state law because the Minnesota Fusion Center (MNFC) is asking that you provide data that are classified as private. Those data are: a daytime phone number that has not been made public (for example a direct line versus the general number for your agency), mobile phone number, email address, and 24 hrs. contact number. You are not legally required to provide any of the data. If you provide the data, they will be used to contact you about reports, cases and inquiries handled through the MNFC. If you do not provide the requested data, you will will not receive Minnesota Fusion Center products. The Minnesota Fusion Center may also provide these private data to other government entities like the U.S. Department of Homeland Security, the FBI, fusion centers in other states, and law enforcement or first responder agencies in other states.

*If you are an undercover officer, all data about you are classified as private. The MNFC does not require that you disclose your undercover status and does not track it. If you register for MNFC products as an undercover officer, the Minnesota Fusion Center will use and share data about you as they do with any other registrant. If this is a problem for your undercover status, please do not register.
