STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Your complainant, a licensed Minnesota peace officer employed by the Minnesota Bureau of Criminal Apprehension, offers the following statement to establish probable cause.

In May 2021, the Minnesota Internet Crimes Against Children Task Force ("ICAC") received six CyberTip reports from the National Center for Missing and Exploited Children that appeared to be associated with one person using a Google account to store images of child pornography. ICAC Agents obtained various administrative subpoenas and identified the account holder as WILLIAM GREEN PINCKNEY (DOB: 5/23/87), the Defendant herein. The Defendant lives on Hemlock Boulevard in Woodbury, Washington County, Minnesota.

On July 22, 2021, at approximately 6:50 a.m., ICAC Agents executed a search warrant at the Defendant's home. The Agents seized several electronic devices capable of storing images of child pornography. The Agents reviewed the devices and found hundreds of files of child pornography, including the following specific files. Each file depicts a different child victim

1. Count 1

File Name: 153043040555.gif (File 2 in the reports)

Description: A video depicting a prepubescent (or at the beginning of puberty) female child between the ages of seven and 12 years old. The child is lying on her back nude from the waist down. The child's face is depicted. The video shows the child touching her vagina, then placing her fingers and thumb in her vaginal opening.

2. Count 2

File Name: 153046330970.gif (File 3 in the reports)

Description: A video depicting a prepubescent female child between the ages of five and ten years old. The child is lying on her back nude from the waist down. The child's face is depicted. The video shows the child touching her vagina.

3. Count 3

File Name: 154660127438.gif (File 4 in the reports)

Description: A video depicting a prepubescent female child between the ages of four and eight years old. The child's face is depicted. The video shows the child lying on her stomach between an adult male's legs performing fellatio on the male.

4. Count 4

File Name: 1586500601313.jpg (File 5 in the reports)

Description: An image depicting two children. One child is a prepubescent (or at the beginning of puberty) female between the ages of six and ten years old. The other child is a prepubescent female between the ages of five and seven years old. The image shows both children nude lying on their backs in a bed. One

child is holding a large phallic sex toy and touching it to the top of the other child's vaginal opening. One child's face is fully depicted, the other child's face is partially depicted.

5. Count 5

File Name: IMGx0618.png (File 7 in the reports)

Description: An image depicting two nude prepubescent female children between the ages of five and ten years old and two adult males. Both males are standing with erect penises. One child is in a handstand with her legs straddling one of the males. The male is holding his penis above the child's butt. The second child is on her knees performing fellatio on the other adult male.

6. Count 6

File Name: IMGx2828.jpg (File 8 in the reports)

Description: An image depicting two nude prepubescent female children between the ages of five and ten years old and two adult males. Both males are standing with erect penises. One male is holding a child upside down while the child performs fellatio on the male. The other child is on one knee performing fellatio on the other male.

7. Count 7

File Name: IMGx4287.jpg (File 9 in the reports)

Description: An image depicting two nude adult males standing next to a kneeling prepubescent female child between the ages of five and eight years old. The child is holding both males' penises. The child's bare chest and pubic area is depicted.

8. Count 8

File Name: IMGx4287.jpg (File 10 in the reports)

Description: An image depicting a split image of two pictures. The top picture depicts a nude female prepubescent child between the ages of four and eight. The child is performing fellatio on an adult male's erect penis. The image has the words, "Such Amazing Suction." The bottom picture depicts a female child from the shoulders up and an adult male with an erect penis. The male's penis is in front of the child's face. The male appears to be ejaculating in and on the child's mouth.

The Agents took a statement from the Defendant. Among other things, the Defendant confirmed he owned the email addresses and Google accounts associated with the CyberTips from the National Center for Missing and Exploited Children. He also acknowledged viewing pornography daily for approximately one hour, but denied downloading or viewing child pornography.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
