



## Enhanced Driver's License and Identification Card Identification Requirements

### Minnesota Rules Parts 7410.0400 to 7410.0410

Only Minnesota residents who are also United States citizens and at least 16 years of age may apply for an Enhanced Driver's License or Enhanced Identification card.

#### IMPORTANT Notes Regarding Identification Documents:

- **VALID Minnesota PHOTO driver's license, permit, or ID:** Is not expired, suspended, revoked, or canceled, and not disqualified for the class of vehicle being operated. Minn. Stat. § 171.01, sub. 49a.
- The **same document may be used** to meet **multiple requirements**, with **exception** of documents used for **proof of full legal name and proof of photographic identity**.
- The **document used for PROOF of FULL LEGAL NAME cannot** also be used as **PROOF of PHOTOGRAPHIC IDENTITY**.
- You must provide original documents or documents certified by the agency that issued them. The document used for Proof of Full Legal Name **cannot** also be used as Proof of Photographic Identity.
- If your name has changed, you must submit proof of **each** name change. Acceptable proof includes a certified copy of a marriage certificate, divorce certificate, or a court-ordered name change.
- Two **different** types of documents must be submitted for **PROOF OF MINNESOTA RESIDENCY**. Only **one** of a document type (List F) will be accepted. For example, an electric bill and phone bill are not acceptable because they are both utility bills. Another document from List F, Documents 2 to 20 must be submitted.
- If you have not updated your name change with the Social Security Administration, you must do so prior to applying for an Enhanced Driver's License or Enhanced Identification Card.
- Laminated documents or documents with any alterations or erasures **will not** be accepted. **All documents are subject to verification.**

**In order to apply for an Enhanced Driver's License or Enhanced Identification card, you'll need to provide documents that meet the following requirements:**

- PROOF OF DATE OF BIRTH** (ONE document from **LIST A**)
- PROOF OF FULL LEGAL NAME** (ONE document from **LIST B**—  
*that is not being used as proof of photographic identity document*)
- PROOF OF SOCIAL SECURITY NUMBER** (ONE document from **LIST C**)
- PROOF OF PHOTOGRAPHIC IDENTITY** (ONE document from **LIST D**—  
*that is not being used as proof of full legal name document*)
- PROOF OF UNITED STATES CITIZENSHIP** (ONE document from **LIST E**)
- PROOF OF MINNESOTA RESIDENCY** (TWO documents from **LIST F**—  
*that have the applicant's current name and address*)

3. Valid, unexpired U.S. passport or U.S. passport card
4. Certificate of naturalization (Form N-550, N-570)
5. Certificate of citizenship (N-560, N-561)
6. American Indian card (Form I-872) or Minn. tribal identification card that meets the requirements of *Minn. Stat. § 171.072*
7. Military photo identification card issued to active, reserve or retired military personnel only

#### LIST B – PROOF OF FULL LEGAL NAME THAT IS NOT BEING USED AS PROOF OF PHOTOGRAPHIC IDENTITY

##### (ONE DOCUMENT FROM THIS LIST—THAT IS NOT BEING USED AS PHOTOGRAPHIC IDENTITY DOCUMENT)

***If your name has changed***, you must submit proof of ***each*** name change. Acceptable proof includes a certified copy of a marriage certificate, divorce certificate, or a court-ordered name change.

1. Original or certified copy of U.S. or U.S. territory birth certificate that bears the raised or authorized seal of the issuing jurisdiction or a protective equivalent
2. United States Department of State Consular Report of Birth Abroad (FS-240, DS-1335, or FS545)

12. U.S. military dependent identification card

13. American Indian card (From I-872) or Minn. tribal identification card that meets the requirements of *Minn. Stat. § 171.072*
14. Valid city, county, state or federal employee identification card
15. U.S. high school ID card with a certified transcript from the school, both issued no more than 180 days before the EDL or EID application
16. U.S. college or university ID card with a certified transcript from the same college or university, both issued no more than 180 days before the EDL or EID application
17. Veterans universal access identification card
18. Minn. unemployment insurance benefit statement issued no more than 90 days before EDL or EID application
19. Federal or state income tax return or statement for the most recent tax filing year
20. Minn. property tax statement for the current year that reflects the applicant's principal residential address both on the mailing portion and portion stating what property is being taxed
21. Minn. vehicle certificate of title if issued no more than 12 months before EDL or EID application.
22. A filed property deed or title for current residence if issued no more than 12 months before EDL or EID application
23. Supplemental Security Income award statement that is issued no more than 12 months before EDL or EID application

##### (ONE DOCUMENT FROM THIS LIST)

1. Original Social Security Card
2. Federal or Minnesota income tax form W-2

5. U.S. employment computer-printed pay stub with applicant's name, address and full Social Security number

3. United States financial information with account numbers redacted including *(Not issued more than 90 days before the EDL/EID application)*:
  - Bank Account statement
  - Canceled check
  - Credit Card statement
4. United States high school identification card with a certified transcript from the same school *(Not issued more than 180 days before the EDL/EID application)*
5. United States college or university identification card with a certified transcript from the same school *(Not issued more than 180 days before the EDL/EID application)*
6. United States employment pay stub that lists the employer's name, address, and telephone number *(Not issued more than 90 days before the EDL/EID application)*
7. Minn. unemployment insurance benefit statement *(Not issued more than 90 days before the EDL/EID application)*
8. Assisted living or nursing home statement *(Not issued more than 90 days before the EDL/EID application)*
9. Life, health, automobile, homeowner's, or renter's insurance policy. *Proof of insurance card will not be accepted. (Not issued more than 90 days before the EDL/EID application)*
10. Federal or state income tax return or statement for the most recent tax filing year
11. Minn. property tax statement for the current year that reflects the applicant's principal residential address both on the mailing portion and portion stating which property is being taxed
12. Minn. vehicle certificate of title *(Not issued more than 12 months before the EDL/EID application)*
13. A filed property deed or title for current residence *(Not issued more than 12 months before the EDL/EID application)*
14. Supplemental Security Income award statement *(Not issued more than 12 months before the EDL/EID application)*
15. Mortgage documents for the applicant's principal residence
16. Residential lease agreement for the applicant's principal residence *(Not issued more than 12 months before the EDL/EID application)*
17. Valid Minn. driver's license, permit or identification card *(Valid license, permit or ID: Is not expired, suspended, revoked, or canceled, and 2. not disqualified for the class of vehicle being operated. Minn. Stat. § 171.01, sub. 49a)*
18. Minn. professional license that is not expired
19. Selective service card that is not expired
20. Military orders that are still in effect at the time of application
