Inter & Intra Agency Bi-Lateral Netting Instructions and Fees

The net purchase price of a vehicle must be typed in the upper right corner where indicated.

The 6.5% sales tax will automatically calculate, display, and complete lines H1, H2, and H3.

Sales tax and fees will automatically calculate and display.

Effective July 1, 2016, the \$1.00 Technology Surcharge (Item K) will no longer be collected.

Effective January 1, 2016, Minnesota law requires all vehicle owners to provide insurance company name, insurance policy number, and the policy expiration date when registering, re-registering or transferring the ownership of all motor vehicles and motorcycles.

The payment form may be used for more than one motor vehicle application. The form must include the signature of the authorized agency agent, agency name, and telephone number.

1. List the vehicle ID number (i.e. VIN or serial number) for each vehicle that you are paying fees for on the payment form. Use additional sheets if necessary to complete the list.
2. Enter the information from the completed form into SWIFT. Record the Purchase Order Number in the upper right corner. Enter the Customer Number in the lower left corner. **DVS will record invoice number when billing.*
DO NOT SEND CASH, CHECKS OR MONEY ORDERS.
3. List corresponding fees and vehicle insurance information (auto insurance company, policy number, and expiration date) on the Application to Title/Register a Vehicle (PS2000).
4. Submit two copies of the payment form with the completed application and all supporting documents to Driver and Vehicle Services at the address listed above. **You may not submit your application to a deputy registrar.**
5. Retain a copy of all documents for your records.
