- To transfer from joint to single ownership (***the fee is due to transfer from single to joint ownership***)
- In a licensed dealer name (if held for resale)
- In the name of a government entity
- In the owner's name listed on the foreign state title or registration card
- For vehicles weighing less than 1,000 pounds
