Permanent Exempt Rules Governing Concurrent Driver Education

Adopted Exempt Permanent Rules Relating to Concurrent Driver Education Curriculum; Definitions; Requirements; Instruction and Enrollment; *Minnesota Rules*, parts 7411.0100, 7411.0210, 7411.0250, 7411.0280, 7411.0305, 7411.0325, 7411.0410, 7411.0515, and 7411.0520; Revisor's ID Number 4255

Summary: Currently, Class D concurrent driver education is allowable in Minnesota; however, there are no definitions for the administrative and curriculum requirements. These rules are necessary for the department to define both concurrent and consecutive driver education to distinguish each program and its requirements.

The Department amended the rules pursuant to its grant of rulemaking authority following the Administrative Procedure Act, as provided under *Minnesota Statutes* §14.386, except that section 14.386, paragraph (b), does not apply; and the specific grant of exempt rule making authority in *Minnesota Laws*, 2013, chapter 117, article 3, section 10, and *Laws*, 2014, chapter 261, section 3.

Amendments to Rules Relating to Concurrent Driver Education, *Minnesota Rules*, Parts 7411.0100, Subpart 10a to 10b; 7411.0210, subp. 7; item I; 7411.0250, subp. 2, Item C, and G; 7411.0280, subp. 1, item B, sub-item (1) to (3); 7411.0305, Item H; 7411.0325, Subp. 3, item B –D and Subpart 4; 7411.0410, item G; 7411.0515, Subp. 2a. and Subp. 2b; and 7411.0520, Subp. 4a.

The rules received a final review and certification from the Office of the Revisor of Statutes on August 21, 2014. The Department filed a request for review of legality and approval of the proposed exempt rules with the Office of Administrative Hearing (OAH) on August 26, 2014. Upon review, Judge Eric L. Lipman determined that the rules were adopted in compliance with the procedural requirements of *Minnesota Statutes*, Chapter 14.386, and *Minnesota Rules*, Chapter 1400, and ordered the rules approved as to legality on September 8, 2014. The rules were approved and filed with Secretary of State, on September 10, 2014.

The rules are available for review on the Public Notice section of the Department of Public Safety website. The Commissioners Order and the adopted rules will be published in the *State Register* on Monday September 15, 2014, and become effective immediately upon publication.
