



## STATE PATROL PSAP CONSOLIDATION NEWS

Minnesota State Patrol is taking advantage of robust public safety technology enhancements occurring in Minnesota. The build out of the 800 Megahertz statewide radio system in combination with the implementation of the Next Generation 911 Emergency Services IP Network (ESInet) has given State Patrol the opportunity to downsize and consolidate their PSAP resources. Over a several month period, eight of ten State Patrol PSAPs will close, leaving only two dispatch centers remaining: Roseville and Rochester.

By combining PSAPs, the State Patrol will have more dispatchers on duty to answer calls and respond to public safety service requests, thereby improving overall customer service.

The 911 network in Roseville has been configured into four geographically arranged trunk groups to assist Roseville PSAP staff to more efficiently process incoming 911 calls throughout the transition period and beyond.

**Important Information for PSAP MANAGERS Regarding Call Transfers to State Patrol PSAPs!!**

The current State Patrol Star Code System will remain in effect throughout the transition period of State Patrol Consolidation – consolidation efforts involving either Roseville or Rochester State Patrols.

All 9-1-1 call transfers from either a county or city PSAP to a State Patrol PSAP should be done using the State of Minnesota Three Digit Star Code System that was implemented in conjunction with the Next Generation Phase 1 Migration in 2010 which provided for improved interoperability between all Minnesota PSAPs.

A 9-1-1 call transferred through the use of the appropriate 3 digit star code will transport the ANI/ALI information along with the voice call to the appropriate PSAP. A 9-1-1 call transferred to a 10 digit administrative line or on a speed dial star code that was programmed prior to 2010 will not display ANI/ALI information with the voice.

**These 3 digit star codes remain in effect throughout the State Patrol Transition Process:**

Using the existing star code scheme, a PSAP will be assured that the call is being directed to the appropriate dispatcher, regardless of physical location of the call taker responsible for answering the 9-1-1 call.

With few exceptions, 3 digit star codes must be programmed by a technician representing your CPE vendor. Throughout the State of Minnesota this is typically either CenturyLink or IES.

This transitional 3 Digit Star Code Program will remain in effect until all eight PSAPs are completed closed. Once that occurs, a single star code will be re-assigned to both the NE Greater MN and the NW Greater MN consolidated trunk groups.

**PSAP MANAGERS:** Please review the State Patrol 3 Digit Star Code List above to validate your PSAP CPE is correctly programmed to complete 9-1-1 call transfers so State Patrol receives ANI/ALI information with a transferred voice call.
