Terms and Conditions

2013-2014 What's Your Winter Photo Contest

Contest Eligibility

Any amateur photographer, except employees and families of The State of Minnesota Department of Public Safety (DPS) may submit photos for judging and potential prizes. DPS reserves the right to verify, in its sole judgment, contest and winner eligibility. Identified DPS members and families may submit photos for display, but are not qualified for judging or contest prizes.

By the act of entering photos in this contest, you represent and warrant that (1) you own or otherwise have all necessary rights to the photo(s) you enter and the rights to enter them and that (2) publication of the photos will not cause injury to any person or entity. Using a name other than your own (or that of your parent or legal guardian) in association with contest entry is prohibited.

Usage Rights

For all photos entered in the DPS "What's Your Winter?" Photo Contest, you grant the Minnesota Department of Public Safety a worldwide, royalty-free, perpetual, irrevocable, non-exclusive right and fully sub-licensable license to archive, store, and create derivative works from such photos in any form, format or medium of any kind, now known or later developed. Without limiting the generality of the previous sentence, you allow DPS to share photos submitted by you across all websites and printed material in any way associated with or produced by DPS, to include them in searchable material or use them in promotional material or advertisements. All these rights are granted without need for compensation of any sort to you.

Do not provide photographs that:

- Are copyrighted or otherwise proprietary in nature
- Contain vulgar, offensive, profane, abusive, racist or distasteful images, or could be perceived as
 defamatory, threatening, misleading or discriminatory on the grounds of race, religion, national
 origin, gender, age, marital status, sexual orientation or disability.
- Deliberately or intentionally advertise or promote any goods or services.

Violation of these rules will cause photos to be rejected and possibly referred to law enforcement authorities.

Entrants must not infringe on the rights of other photographers or submit images that involve willful harassment of wildlife or damage to the environment by the photographer.

DPS is committed to protecting the privacy of users in accordance with Minn. Stat. § 13, the Minnesota Government Data Practices Act; this privacy statement explains how. We reserve the right to alter our privacy policy as business needs require.

Information Collected and Used

If you visit our sites to browse, read, and/or download information, the following information is collected and used.

We use "cookies," the small text files that our websites place on your computer's hard drive to collect information about your activities on the sites. We collect and store the Internet Protocol (IP) address for the computer you used to access the sites; the identification of your browser software and operating system; the date and time you accessed the sites; and the Internet address of the website from which you linked directly to our sites.

We use this information to measure the number of visitors to the different sections of our sites and to help us make our sites more useful. We cannot and do not associate any of this information with individual persons, distribute this information to any third parties, or use it in any manner other than for statistical analysis in improving our sites for visitors. This information is classified as private or nonpublic. We retain this information indefinitely.

If you choose to identify yourself by submitting a photograph or sending us an email or completing our online forms, we use the personally identifying information to process or respond to your request. If you complete an online form, the information you provide is up to you. However, if you do not provide certain information, such as your name, it may be impossible for us to respond to your request.

DPS Websites use industry standard technology for secure online transactions. We may retain this information in our files, either in electronic form or hardcopy. Some of this information is public data under the Minnesota Government Data Practices Act.

Information emailed to us via the Internet is not secure and can be intercepted and read by others. We recommend that you not use email to send us private or sensitive data about yourself or others unless the data is encoded or encrypted. Also, users are cautioned that the collection of personal information requested from or volunteered by children on-line or by e-mail will be treated the same as information given by an adult and may be subject to public access.

Photographs and Images

Photographs and images posted on the Department of Public Safety Websites are licensed material. The Department of Public Safety prohibits downloading any and all photographs or images for purposes other than personal use. Licensing restrictions prohibit republication, retransmission, reproduction, or other use of the licensed material.

Your Rights as the Subject of Government Data
