

Crime Victim Funding for Unmet Needs RFP Applications Funded

Advocates for Family Peace

\$59,304 to provide direct advocacy services to victims of domestic violence in northern St. Louis County.

Alexandra House

\$64,246 for on-site sexual assault and domestic violence intervention services in the Columbia Heights and St. Francis school districts, as well as youth support groups at Lino Lakes Juvenile Shelter (non-secured and secured programs) and presentations to youth at the East Regional Juvenile Center.

Casa de Esperanza

\$81,049 to increase the provision of domestic violence advocacy services for the Latino population in the Twin Cities.

Central Minnesota Sexual Assault Center

\$51,397 to provide outreach, appropriate resources and culturally appropriate services to sexual assault victims from the Somali and Latino communities in Stearns, Benton, Sherburne and Wright counties.

Committee Against Domestic Abuse

\$61,636 for an Aftercare Advocacy Program to assist victims of domestic violence in obtaining and sustaining stable housing in the 9-county region of south central Minnesota.

Cornerstone Advocacy Services

\$43,710 for a full-time Community Advocate housed at the Northwest Hennepin County Service Center to provide domestic violence services for those living in Northwest Hennepin County.

Family Partnership, The

\$80,000 for the PRIDE program's Safe Harbor Expansion, increasing direct services and support for youth identified as victims of sex trafficking/commercial sexual exploitation/prostitution and youth sex trafficking victims who belong to special populations, including LGBTQ youth and Somali youth.

Family Service Rochester, Inc.

\$29,420 to meet the increase in demand in Olmsted County for parenting time services per week, per family, due to the court's decision to permit more parenting time visits via court order.

First Witness Child Abuse Council

\$25,397 to provide follow-up services for children, who as a result of their forensic interview, are in out-of-home placement in St. Louis County.

Grand Portage Tribal Council

\$59,304 for a Domestic Violence Advocate based on the reservation, from whom victims of domestic, sexual and other forms of abuse can access advocacy services.

Greater Minneapolis Council of Churches

\$59,304 for a Traditional Counselor/Advocate in the Family Violence Program to provide cultural healing advocacy to Native American victims of violence.

Hands of Hope Resource Center

\$18,285 for an increase in direct service advocacy staff time to address domestic violence service needs in Morrison and Todd counties.

Hmong American Partnership

\$59,304 for a Licensed Independent Clinical Social Worker (LICSW) to work in the culturally specific GRIPP Program serving young Hmong women who are victims of sexual assault, stalking, dating violence and trafficking.

HOPE Center

\$35,583 to provide culturally specific services to Latino/Hispanic victims of crime who have experienced sexual assault, domestic violence or stalking in Rice County, in collaborative partnership with agencies serving this population.

HOPE Coalition

\$13,224 to provide, in collaboration with the agency, SARA, ongoing community support group services to survivors of domestic and sexual violence in Goodhue and Wabasha counties.

Immigrant Law Center of Minnesota

\$56,339 to provide legal assistance to immigrant victims of domestic and sexual violence in Winona, Mower, McLeod, Nicollet, Le Sueur, Blue Earth, Steele, Freeborn, Lyon and Watonwan counties, in collaboration with specific agencies serving immigrants in these counties.

Leech Lake Band of Ojibwe

\$51,465 for direct advocacy staff providing domestic violence and sexual assault services on Leech Lake Reservation.

Missions, Inc.

\$49,766 to provide domestic violence services for immigrant and refugee battered women and their children in northwest Hennepin County.

Pennington County Attorney's Office

\$46,455 to increase direct service hours for victims of general crime who would otherwise not have an advocate available.

Program for Aid to Victims of Sexual Assault

\$59,067 to provide direct services to victims of sexual assault who are incarcerated in prisons, jails and detention centers, in partnership with correctional facilities working to meet their Prison Rape Elimination Act (PREA) requirements.

Rape and Abuse Crisis Center

\$57,963 to increase advocacy staffing to address increased needs for criminal justice legal advocacy, elder abuse, services to Native American and immigrant/refugee clients, and supervised visitation and safe exchange services in the Fargo/Moorhead area.

Red Lake Band of Chippewa Indians

\$59,219 to provide legal advocacy services to victims of domestic and sexual violence at Red Lake Tribal Court and Beltrami County Court.

Safe Avenues

\$59,304 to provide advocacy services for Latino/Hispanic immigrant victims of domestic and sexual violence in Kandiyohi and surrounding counties.

Sexual Assault Program of Beltrami, Cass and Hubbard Counties

\$49,420 to increase direct service advocacy staffing to provide sexual assault services in Cass and Hubbard counties.

Sojourner Project, Inc.

\$23,722 to provide, in collaboration with Domestic Abuse Project, therapeutic services for women and children.

Someplace Safe

\$57,252 to provide increased domestic violence, sexual assault, general crime and parenting time center services in the 9-county service area of west central Minnesota.

Southwest Crisis Center

\$53,483 for additional advocacy staff to serve domestic violence and sexual assault victims in Jackson and Pipestone counties.

Support Within Reach

\$41,458 to increase advocacy staff hours and establish support groups for victims of sexual assault in Itasca and Aitkin counties.

\$59,304 to provide domestic violence and sexual assault services in Carlton County.

Winona County Attorney's Office

\$36,620 to provide general crime services in Winona County.
