Rights and Services for All Crime Victims

1. You have the right to apply for financial help for losses resulting from a violent crime. This assistance does not cover property losses. For application information, call **(651) 201-7300 or (888) 622-8799**, TTY: 651-205-4827, or go to the OJP Website: ojp.dps.mn.gov.
2. You have the right to request that the law enforcement agency withhold public access to data revealing your identity. The law enforcement agency will decide if this is possible.
3. You have the right, if an offender is charged, to be informed of and participate in the prosecution process, including the right to request restitution (money that is court-ordered from the offender & paid to the victim).

Victims of Domestic Assault

1. You can ask the city or county attorney to file a criminal complaint.
2. You have the right to go to court and file a petition requesting an Order for Protection from domestic abuse. The order could include:
 - a. an order restraining the abuser from further acts of abuse;
 - b. an order directing the abuser to leave your household;
 - c. an order preventing the abuser from entering your home (or a reasonable area around your home), school, business, or place of employment;
 - d. an order awarding you or the other parent custody of/or visitation of your minor child or children; and/or
 - e. an order directing the abuser to pay support to you and the minor if the abuser has a court order to do so.
3. You have the right to notification if prosecution of the case is declined or criminal charges are dismissed.

University Victims of Sexual Assault, Domestic Assault, Dating Violence, and Stalking

1. You have the right to request and be provided, if reasonably available, changes to academic, living, transportation, and/or working situations and other protective measures to safeguard you from the offender. You have this right even if you decide not to pursue a formal complaint. For assistance, contact the UMD Women's Resource and Action Center (WRAC) at **(218) 726-6292** or the UMD Office of Student Conduct at **(218) 726-7255**.
2. You have the right to seek a no contact order against the offender. For information and assistance, contact the UMD Office of Student Conduct at **(218) 726-7255**.
3. You have the right to receive a written notice of your rights and information about helpful services, including referrals to community advocates, when you report your victimization.
4. You have the right to file a complaint and participate in University disciplinary proceedings against the offender and to know the outcome, subject to data practices laws. An advocate, attorney, or other support person may accompany you to any investigation-related meeting or proceeding. For information and assistance, contact the UMD Office of Student Conduct at **(218) 726-7255**.
5. You have the right to make an anonymous online report of sexual harassment and/or sexual violence at UReport on the University website or by calling UReport (Ethics Point) at **(866) 294-8680**, however, this report will not necessarily be investigated unless a formal complaint is made to the UMD Office of Student Conduct at **(218) 726-7255**.

For a comprehensive description of your rights and options as a victim, please refer to the University's Notice of Complainant Rights that was provided to you when you made your report.
