STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Your Complainant is a law enforcement officer with the Hastings Police Department.

Acting in that capacity, I have reviewed the police reports and believe the following to be true.

On March 10, 2010, the Hastings Police Department received a referral from Dakota County Child Protection of a sexual assault involving a 15-year old girl (hereinafter Victim). Victim was currently residing in a treatment facility and had disclosed to a counselor that she had recently had sexual contact with a former boyfriend in Hastings. Victim was interviewed by an investigator, and she disclosed that on February 26, 2010, she had engaged in sexual penetration with her former boyfriend, Josh John Coyle. She said the incident took place at a residence in the City of Hastings, Dakota County, Minnesota. She said she had not really wanted to have sex with Coyle, but he was insistent and she was hoping to win him back. She told the officer that Coyle had engaged in both digital and penile penetration of her vagina.

Coyle was interviewed on April 14, 2010. Coyle admitted having sex with Victim and that he was 18 years old and Victim was 15 at the time.

**NOTICE:** *You must appear for every court hearing on this charge. A failure to appear for court on this charge is a criminal offense and may be punished as provided in Minn. Stat. §609.49.*

Complainant requests that Defendant, JOSH JOHN COYLE, subject to bail or conditions of release, be:

- (1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court, or
- (2) detained, if already in custody, pending further proceedings, and that said Defendant otherwise be dealt with according to law.
