The Bylaws of the Statewide Emergency Communications Board prescribes the membership of its NG911 Committee as follows:

*Membership is comprised of one primary and one alternate from each of the following: Emergency Communication Networks Division, Minnesota State Patrol, Minnesota Sheriffs' Association, Minnesota Chiefs of Police Association, Minnesota State Fire Chiefs Association, Minnesota Ambulance Association, Minnesota Indian Affairs Council or Tribal Government, Tribal PSAP, Minnesota County Geographical Information System Association (MCGISA), and each regional emergency services board or regional emergency communications board.*

*Membership may also include non-voting seats representing non-government and private industry partners at the discretion of the committee and the Statewide Emergency Communications Board.*
