Tau ncuva sijhawm dhau caij rau koj daim lais xeex tsav tsheb lossis koj daim npav vim txoj cai pab rau xwm txheej COVID-19 (Chapter 71, 2020 Minnesota Session Law, and Regular Session).

Cov ntawv lais xeex tsav tsheb Commercial (CDL, commercial driver license) yog tswj los ntawm Federal Motor Carrier Safety Administration (FMCSA, koom haum saib xyuas kev xyuam xim ntawm neeg tsav tsheb). Sijhawm ncuva rau FMCSA cov lais xeex tsav tsheb yuav tag rau Lub 2 Hlis tim 28, 2021. Yog tias koj daim ntawv uas kws kho mob (medical certificate) sau rau koj tau dhau caij rau Lub 9 Hlis tim 1, 2020 lossis tom qab ntawd lawm, koj yuav tsum xa ib daim tshiab tuaj thiab daim ntawv ntiag tug (self-certification) kom koj thiaj li muaj npe txuas mus ntxiv. Yog koj tsis xa koj daim ntawv uas kws kho mob sau rau koj ces yuav muab koj daim CDL txo hloov. Koj xa tej ntaub ntawv tuaj tau hauv online ntawm [drive.mn.gov](http://drive.mn.gov).

- Thov nco tseg tias feem ntau tej chaw haujlwm no xav kom koj nav maim teem sijhawm mus ntsib lawv. Mus xyuas nyob hauv [dvs.dps.mn.gov](http://dvs.dps.mn.gov) ces nias "locations" kom thiaj li qhia tau tej chaw khiav ntaub ntawv nyob ze koj thiab mus teem tau sijhawm.
- Thov mus tso npe ua ntej nyob hauv online ntawm [drive.mn.gov](http://drive.mn.gov) ua ntej mus rau hauv ib lub chaw haujlwm khiav ntaub ntawv. Kev tso npe ua ntej yuav ua rau lub sijhawm khiav ntaub ntawv mus ceev dua thaum koj tuaj thiab yuav pab koj npaj txhij tej ntaub ntawv los ua tiav tom chaw khiav ntaub ntawv.
- Ib txhia chaw xeem DPS-DVS nyob hauv cheeb tsam yuav qhib rau Hnub 6 (Saturday) pib Lub 2 Hlis tim 20 mus txog Lub 3 Hlis tim 27 los pab khiav ntaub ntawv. Yog xav paub tej chaw khiav ntaub ntawv thiab cov sijhawm qhib ces mus xyuas nyob hauv [drive.mn.gov](http://drive.mn.gov) thiab mus nias "news" ces xaiv COVID-19 FAQs.
- Yog tias koj muaj ib daim ntawv hla tebchaws (U.S. passport) koj tsis tas nij ua ib daim REAL ID. Koj siv tau koj daim ntawv hla tebchaws mus nkag rau tej tsev ua haujlwm uas yog tsoom fwv li lossis caij tau dav hlau. Yog xav paub seb yuav ua cov ntaub ntawv twg thiaj li zoo rau koj lossis xav paub ntxiv mus xyuas nyob hauv [drive.mn.gov](http://drive.mn.gov).
