# Communications Toolkit: Driver's License for All and DVS Language Project Resources

Two important Minnesota Department of Public Safety Driver and Vehicle Services (DVS) division initiatives are making customer interactions with DVS easier and expanding access to services for many Minnesotans.

**Driver's License for All** and the **DVS Language Project** are exciting new DVS programs that your employees, students, neighbors, clients, customers, visitors, patients and guests may find helpful and, in some cases, life changing. **We are hopeful you'll help us spread the word about these initiatives.** This communications toolkit has been created with tactics you can use in your organization's various communication channels to share information broadly.

#### More about the initiatives

**Driver's License for All:** Starting Oct. 1, 2023, Minnesotans can apply for a standard Minnesota driver's license, permit or identification card regardless of immigration status. Ensuring drivers are licensed and carry insurance makes the roads safer for all Minnesotans.

PLEASE NOTE: Appointments for starting the license process are essential to minimize wait times at service centers (visit <u>drive.mn.gov</u> and click on "Schedule an Appointment").

**DVS Language Project:** A multilingual virtual assistant (VA) leverages Google artificial intelligence and makes interacting with DVS better for all DVS customers when they visit the DVS website. Online visitors can use the VA to ask questions, gather information and research topics in English, Hmong, Somali and Spanish. The VA provides answers to the most common questions DVS receives on any given day. Users can also update their insurance and obtain individualized records — like their driver's license status and status of their plates and title.

#### How to use the toolkit

The information in this toolkit is a starting point. You can customize these templates and add graphics or images to boost visibility and engagement. Use the messages and information to develop content for emails, newsletters, social media posts, meetings or in conversations. Here's what's included:

- Email to send to your staff: employees, volunteers and consultants.
- Newsletter articles short and to the point that can be included in electronic or print versions.
- Social media posts that benefit your organization's followers.
- A letter to the editor of your local newspaper.

#### **EMAIL or LETTER FROM YOUR ORGANIZATION'S LEADER**

I want to make you aware of two important programs that our state recently initiated in the Minnesota Department of Public Safety Driver and Vehicle Services (DVS) division. These programs can benefit our employees, customers and others we consider an integral part of our organization. *In fact, they can be lifechanging.* Here's what you need to know.

**Driver's License for All:** Do you know someone who is at least 16 years old and doesn't have a driver's license? Starting Oct. 1, 2023, Minnesotans can apply for a standard Minnesota driver's license, permit or identification card regardless of immigration status. Ensuring drivers are licensed and carry insurance makes the roads safer for all Minnesotans.

**DVS Language Project:** I know friends and colleagues who sometimes must translate information for their non-English speaking relatives. Children are often the ones with this task. But **a virtual assistant (VA) in multiple languages is available now on the DVS website.** This amazing technology innovation will make interacting with DVS better for customers who speak Hmong, Somali, Spanish and English. Online visitors can use the virtual assistant to ask questions, gather information and research topics in those four languages. The VA provides answers to the most common questions DVS receives on any given day. Users can also update their insurance and obtain individualized records — like their driver's license status and status of their plates and title. No more waiting in line (or using PTO time) for answers to basic license or driving questions.

There are numerous benefits for our organization and our state with these programs, such as knowing that our roads will be safer: Licensed drivers are familiar with Minnesota driving laws, have demonstrated the skills to safely operate a motor vehicle and must be insured.

## **NEWSLETTER or EMAIL BLURBS: Multilingual virtual assistant**

Did you know the Minnesota Department of Public Safety Driver and Vehicle Services (DVS) division has new tools for making interactions like renewing your vehicle's tabs or getting a driver's license easier for everyone? DVS now has a multilingual virtual assistant available in Hmong, Somali, Spanish and yes, English, on its <a href="website">website</a>. On the bottom right, just click on Help. Visitors can ask questions and research topics in a chosen language. No more standing in line just to get a question answered or check the status of an item.

Employees who take PTO to help family members with limited English ability seek care, buy food or access other services know how difficult that can be. The good news? Minnesota Department of Public Safety Driver and Vehicle Services (DVS) division has a new multilingual virtual assistant available on its <a href="website">website</a>. Click Help in the bottom right corner to ask questions like "What is the status of my car's title?" Selecting the language first — English, Hmong, Somali or Spanish — allows the interaction to be in the language a user understands best.

Cuando vence mi licencia de conducer? (When does my driver's license expire?) Thousands of Spanish speakers have tried the new multilingual virtual assistant from Minnesota Department of Public Safety Driver and Vehicle Services (DVS) division. The assistant provides answers to common questions that DVS receives from customers and makes interacting with DVS better and easier for English, Hmong, Somali and Spanish speakers. No more waiting in line for answers to quick questions. Click Help in the bottom right of the DVS website.

A new tool is now available that will make interacting with the Minnesota Department of Public Safety Driver and Vehicle Services (DVS) division better for customers who speak English, Hmong, Somali and Spanish. The new multilingual virtual assistant uses Google artificial intelligence — which means it gets smarter and better the more it is used. Ask questions, gather information and research topics in whatever language the user knows best. Click Help on the bottom right of the DVS website.

Researchers say that slightly more than 8 percent of the U.S. population does not speak English very well. They are more comfortable or better at speaking other languages, like Spanish, Somali or Hmong. Imagine going to a grocery store or other business. English words would be a blur of nonsense. At the Minnesota Department of Public Safety Driver and Vehicle Services (DVS) division, a new innovation for making interactions easier starts with a multilingual virtual assistant. Web visitors can find what they need in a language they understand: Spanish, Somali, Hmong or English. To try it, go to drive.mn.gov and click Help at the bottom right.

"I just want to know the status of my driver's license."

"I wish I could quickly learn the status of my car title."

Click Help on the bottom right corner of the Minnesota Department of Public Safety Driver and Vehicle Services (DVS) division website. The department's new multilingual virtual assistant might be just what you need. Launched recently, the virtual assistant provides help for common questions in English, Spanish, Somali and Hmong. It's part of the department's ongoing commitment to improve services for all Minnesotans. By solving the problems for users who struggle the most with accessing our services due to language barriers, DVS is better for everyone. And the virtual assistant will direct customers to the appropriate DVS contact information source if it cannot answer a question.



#### **NEWSLETTER or EMAIL BLURBS: Driver's License for All**

Did you know that all Minnesota residents can apply for a license under the new Driver's License for All Law beginning Oct. 1, 2023? The law allows immigrants lacking permanent legal status to obtain or begin the process of obtaining a standard Minnesota driver's license or identification card. The program removes barriers to legally obtain a standard driver's license, permit or state-issued ID card by eliminating the requirement that the applicant provide proof of legal presence in the United States. Information on how to prepare for the start date is available on the website.

Why would Minnesota create a program like Driver's License for All? The program, which many other states also have initiated, ensures drivers are licensed and carry insurance. Simply by providing individuals without proof of legal residence access to legal driving and valid identification, our roads are safer for all Minnesotans. Approximately 81,000 residents are eligible. More information is available on the DVS website.

Current Minnesota state statutes require applicants for driver's licenses, permits and identification cards to demonstrate proof of lawful presence in the United States. But that is changing on Oct. 1, 2023. Immigrants lacking permanent legal status can begin the process to obtain a standard Minnesota driver's license or identification card — and use their new driving skills to find work. Five things to know about Minnesota's Driver's License for All Law:

- 1. The law allows immigrants lacking permanent legal status to obtain a standard Minnesota driver's license or identification card.
- 2. This expands access to resources and services within the community, including work and education opportunities. Roadway safety is improved since licensed drivers go through behind the wheel training, carry insurance, are familiar with Minnesota driving laws and have demonstrated the skills.
- 3. Approximately 81,000 individuals living in Minnesota are eligible.
- 4. The law takes effect Oct. 1, 2023.
- 5. More information is available here.

All Minnesota residents can start the process to apply for a driver's license under the new Driver's License for All Law beginning Oct. 1, 2023. The law allows immigrants lacking permanent legal status to obtain a standard Minnesota driver's license or identification card. The documents required for Driver's License for All are listed at drive.mn.gov. Click on "DL FOR ALL" in the upper left corner. After studying the driver's manual, those interested can make an appointment on Sept. 2 to start the process. Online scheduling is available for Driver and Vehicle Services (DVS) locations at drive.mn.gov under the "Appointments" section. Learn more here.

Getting a driver's license is a major milestone to becoming an adult. And having a driver's license has many benefits — including being able to get to work or education classes. We're excited that starting Oct. 1, 2023, all Minnesotans, regardless of immigration status can begin the process to obtain a standard Minnesota driver's license or identification card. A driver's license is proof that someone has taken the time to learn what is involved in using a vehicle on a road. This is essential to legally drive in Minnesota. Very soon anyone, regardless of immigration status, can learn about driving, take a driving test and obtain a standard Minnesota driver's license or identification card. To try it, go to drive.mn.gov and click Help at the bottom right. Help is available in Spanish, Somali, Hmong or English.

To the editor:

It happens more frequently than most people know: A perfect job candidate for a tough-to-fill position can't accept a job because he or she lacks a driver's license and transportation. In an economy with too many jobs and too few applicants, the new Driver's License for All law removes the barriers to legally obtain a standard driver's license, permit or state-issued ID card by eliminating the requirement that the applicant provide proof of legal presence in the United States. At <Insert name of organization>, we applied our state for this law that provides equity and compassion.

The state estimates that 81,000 individuals can now receive a standard license to drive. And they'll receive driver's training, making the roads safer for everyone. For Hmong, Somali and Spanish speakers with limited English skills, the Minnesota Driver and Vehicle Services division now has an online language tool to make interactions easier and better. Looking forward to the economic and societal impact of these important initiatives!
