- A. Commissioner of Department Public Safety (DPS) Mona Dohman
  - i. The basic assessment of Homeland Security hasn't changed much over the past few years, which isn't really a good thing.
  - ii. There's a big need for a level of awareness.
  - iii. There's an increase in homegrown violent extremists' who can strike with little or no notice.
    - Increase public awareness and vigilance continuously.
    - No tip is too big or too small.
    - Help spread the message, "If you see something, say something".
  - iv. MN Threat Assessment
    - No reported credible threats for Minnesota.
  - v. The Ryder Cup Tournament is coming up.
    - Being an international golf tournament, it could be a target.
  - vi. We are in the planning stages for the 2018 Super Bowl.
  - vii. As we move forward to all of these events and work through these events, we need to remember to educate the people around us in the communities "If you see something, say something".
  - viii. Other events to keep in mind:

- B. Commissioner of Minnesota Department of Health (MDH) Ed Ehlinger
  - i. The 9/11 anniversary is a reminder of how the world has changed and gave us a chance to look back over 15 years today.
    - What worked and what didn't work and we can learn from that.
  - **ii.** We all prepare in different ways, as a reminder as we prepare to prevent a disaster.
  - iii. Get your flu shot.
    - That is emergency preparedness.
  - iv. There has been a release of obesity data.
    - Obesity is a national security issue.
  - v. Working on reducing diabetes.
    - Diabetes is a huge problem, just waiting to explode.

A. A motion was made and seconded. The consensus was taken and passed.

# 7. MDH Report

- A. Judy Seaberg, MDH Healthcare Preparedness reported: The Statewide Burn Surge Plan is near completion. There are two American Burn Association certified burn centers in MN. We have developed 10 burn surge facilities across the state that can hold a patient for 72 hours before transfer. Expect there will be exercises of the burn surge plan. MDH is also developing a Crisis Standards of Care plan. This would be used during events that would necessitate an alternate standard of care. The overarching draft plan is done and will be sent to the Crisis Standards of Care Steering Committee for further comment and revision. A contract with the University of MN Center for Bioethics is in place to develop the ethical framework for Crisis Standards of Care. A public engagement component will follow to make the public aware of the plan. Will look to members to help with the initiative. Judy also reported that the Ebola State Concept of Operations plan is ready to be distributed. She noted that the statewide mobile medical team in Central Minnesota can provide medical care for FEMA Type 1 or 2 emergencies.
- B. Cheryl Petersen-Kroeber, MDH Director of Emergency Preparedness and Response reported that Operation Northern Lights is an example of many different partnering agencies participating together. She said that MDH will be replenishing ChemPacks this fall. One Cache will be moving to a new location. MDH hired a new regional Public Health Preparedness Consultant for the Metro. The public health preparedness funding opportunity for the next five year project period is expected in January 2017. The Emergency Preparedness and Response Management Team will be doing strategic planning to prepare for the next project period. The Health Partnerships Division has hired a communications coordinator, who will be working closely with Emergency Preparedness and Response. Currently, she is working on Zika communications. She will also be doing outreach with partners at the local level in the future. Super Bowl planning has started and both state and local health departments are working on being ready. The Centers for Medicare & Medicaid Services (CMS) published new emergency preparedness requirements for certified health facilities in the US. The requirements will go into effect November 2017. The State Community Health Services Advisory Committee (SCHSAC) Public Health Emergency Preparedness Oversight Group met to discuss the reduction in funding for the PHEP grant. A subcommittee of the work group, Funding Formula, developed a revised funding formula for the next five year project period. The formula will be recommended to the full SCHSAC and if approved, will be used starting with the first budget period of the next five year cycle (beginning July 1, 2017).
